## Required Information:

- a. Prospective MSE buyers are required to submit the copy of valid CTO issued by CPCB/SPCB for manufacturing of Ash based products or copy of valid MSE registration to participate in EOI cum tender process.
- b. The prospective buyers are required to submit particulars of the firm with the background of operation, business where ash will be utilized, tentative plan, and proposed quantity of fly ash to be utilized etc. along with their latest balance sheet.
- c. The buyer submitting the EOI cum Tender shall be bearing all costs associated with the preparation and submission of the EOI cum Tender and RPL will, in no case be responsible or liable for these costs, regardless of the conduct or outcome of the assessment/evaluation process.
- d. Eligible buyers shall deposit Earnest Money Deposit (EMD) of Rs 1,00,000 in the form of DD in the favour of RattaIndia Power Limited with EOI cum tender document and same shall be returned within 2 months from bidding date if bidder is not qualified / successful.

All documents submitted shall be duly self-certified by the participant as being true and authentic. Interest / Offer / Bid is liable to be rejected if documentation is not complete.
6. Turnover certificate certified by chartered accountant and audited financial of last 3 years (Balance sheet and P&L sheet).

## Allocation of FLY ASH:

Based on the time of receipt of responses to EOI cum Tender Document, FLY ASH shall be allocated to various bidders on highest bidding value to lowest bidding value, till the available offered quantity is exhausted. However, collecting from RATTANINDIA POWER LIMITED's issue location and transportation, thereafter, will be in the scope of the bidder only.

*Daily allocation of FLY ASH shall be done as given below:*

1. *All successful bidders shall submit a monthly requisition containing a list of their day wise requested quantities for each month by the 22nd of the previous month. In case any bidder proposes to collect the ash through Rail (subject to Rail Loading Facility being available at the station), same shall also be indicated in this requisition subject to RPL Management approval only.*
2. *Based on above, corresponding annual allocated quantity and availability. RATTANINDIA POWER LIMITED shall determine and intimate the day wise allocation for each month by 28th of the previous month. Bidder to submit 30 days advance payment prior to the schedule and accordingly for next month.*
3. *All allocated bidders (or transportation vendors) shall be expected to follow the above schedule and mobilize accordingly with action plan approved by RPL EIC.*
4. *In case of non-mobilization / inadequate mobilization, RATTANINDIA POWER LIMITED may, at its discretion, allocate such quantity to alternate bidder(s) / avenue(s). Decision of Engineer in Charge (EIC)- RATTANINDIA POWER LIMITED shall be final and binding in this regard.*

FLY ASH shall be issued from the, the designated area of Ash Dyke(s) / Pond(s) or other location as decided by EIC of the respective RATTANINDIA POWER LIMITED Station, on 'as is where is' basis.

#### Refundable Security Deposit (SD):

The Successful Bidder shall be required to submit a Refundable Security Deposit equivalent to the sale value of one month's ash (calculated based on monthly volume and bid rate), along with the submission of LOA/LOI acceptance, following the evaluation of submitted requests and completion of the Ash Allocation Process. This Security Deposit will be retained to ensure the commitment of the Successful Bidder(s) to lift the allocated ash. If the bidder fails to lift the entire committed quantity within the specified period, the Security Deposit shall be forfeited.

The Security Deposit shall be refundable after adjustment of any recoverable amount, if applicable. The adjusted Security Deposit will be refunded within 30 days from the end of the contract period or upon lifting of the entire allocated quantity, whichever occurs earlier.

Arrangement with Railways, Freight charges payable to Railways, haulage charges and other charges as applicable in case of transportation by rail in Environment friendly manner, will be in my / our scope. While I / we understand that the Station may at its discretion, consider part / full facilitation for lifting of FLY ASH through rail – mode / road cum rail mode, subject to feasibility and cost economics, I / we also understand that I /we shall have no claim whatsoever, in this regard.

## Part 6: Terms and Conditions and General Guidelines:

1. FLY ASH shall be issued from, the designated area of Ash Dyke(s) or other location as decided by EIC, to the Successful Bidders (or their authorized representatives as may be agreed to in writing by the EIC based on approval by Station Head), considering Operational and Safety issues of Ash dyke.
2. Bidders shall make themselves aware of the various extant Rules, Procedures, Safety norms, Environmental and Sustainability Guidelines etc and carry out their activities in full compliance with the same.
3. No person / agency shall be allowed to lift ash without due permission from Amravati TPP.
4. General facilitating measures for lifting of Ash viz. Common Approach / ramp, general area fugitive dust suppression, weighment of Ash etc. shall be in the scope of RATTANINDIA POWER LIMITED. However, job specific facilitation viz. approach / ramp to specific allocated area and local fugitive dust suppression shall be in the scope of the recipient agency.
5. Bidders eligible for collecting FLY ASH shall apply for permission for the closed / covered Trucks / other suitable transportation medium that they propose to deploy and submit the same to EIC along with specified documents like registration, license, insurance etc., who shall arrange to verify the same and issue permission as per prevailing procedure adopted at the Station.
6. Depending upon operational convenience, safety, etc. EIC can schedule the lifting of Ash from Designated storage area by different agencies, which shall be binding upon the agencies. The schedules and deployment may be worked out / altered based on periodic meetings between concerned stakeholders. Agencies shall mobilize with adequate manpower, vehicles and machinery within 15 days of issue of communication from the EIC.
7. T&Ps, excavation, loading and transportation of Ash shall be in the Scope of the recipient(s).
8. Statutory / regulatory compliances shall be binding upon all the Bidders and verifiable by TPP.
9. Non – compliance shall attract penal actions ranging from fine to termination of contract / agreement / issue of FLY ASH as decided by EIC
10. Transportation of Ash shall be in the Scope of the Successful Bidder(s).
11. Road Permits, Operator / Driver Licenses, Insurance etc. for the deployed Vehicles shall be submitted at the time of start of work (and also when new and / or additional vehicles are deployed) and thereafter as and when demanded by the EIC for verification. The vehicles shall be in fit condition for safe operation.
12. Successful Bidders shall submit affidavit on Non – judicial stamp paper of requisite value, certifying the complete Utilization of issued FLY ASH, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
13. In case of any liability on ATPP, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Bidder or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Successful Bidder shall keep TPP effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Ash.
14. RATTANINDIA POWER LIMITED reserves its right to take appropriate action as deemed fit, in case information / details provided are found false even at a later date.
